Human rights standards must be put at the heart of MDG in order to fulfill the promises made in Millennium Declaration. - Amnesty International agrees with Forum for 21st Century that after experience of World War II when fundamental human rights were gravely violated as a reaction to the war the Universal Declaration of Human Rights was adopted in 1948 within the United Nation. The Declaration sets down the basic principles at the very heart of the human rights movements. It has enabled remarkable progress in human rights, inspiring international human rights standards, laws and institutions that have improved lives of many around the world. Amnesty International agrees with Forum for 21st Century that every state out of 184 members should respect the rules they signed for. However because the Universal Declaration for Human Rights is not legally binding, the governments are not forced to do so. Amnesty International is aware of cultural diversity of each country and also that the perception of the human rights may differ from country to country. The organization agrees with the Forum for 21st century that political system with its legislation is entity which sets and implements human rights. On the other hand Amnesty International believes that principles of Universal Declaration of Human Rights and other international human rights standards and treaties defines, harmonize and unify the term "human rights"
- Amnesty International agrees with Forum for 21st Century that many international documents, treaties and declarations were adopted during last decades. The problems every such documents faces is that, for example, although as many as 184 states signed the Universal Declaration for Human Rights, there is no legal system that would enforce these states to punish them for violating what they signed for. In recent history, millions of victims of genocide, crimes against humanity, war crimes, torture, extrajudicial execution and enforced disappearance have been ignored by national authorities. For these circumstances the campaign demands justice, truth and full reparations for victims of serious human right violations.
- Amnesty International supports the idea of establishing the international tribunal to investigate and prosecute crimes when national authorities are unable or unwilling to do so. In fact Amnesty International began its campaign for establishment of International Criminal Court in 1993. AI participated in drafting a Rome Statute of the Court and it was adopted in July 1998. Since the Rome Statue was adopted more than half of the words nations have ratified it. The only country that strongly opposed the Court was United States of America; however it position has changed in recent years. At the time the main goal of Amnesty International is: a) all governments ratify the Rome of Statute, b) the governments implement legislation and would be able to prosecute crimes before national courts and fully cooperate with the International Court, c) all governments will fully cooperate with the Court in investigating and prosecuting the crimes, d) there would be created The Assembly of States Parties made up of countries that have ratified the Rome Statute.

The key document at all Amnesty International is doing is the Universal declaration of Human rights.
