- Which is clearly for the performance of the human rights, not only in our country, but around the world. In case of our country, human rights have been supported by the government and therefore The Mexico's National Human Rights Commission., and many other national organizations, mostly NGOs were created. The main porpose for creating these organizations was protection of the human rights in our country, promotion and challenge to maintain them, but the most important reason is to reducing problems we have had, and still we have. I mean some kind of problems like torture, police repression, sexual murder, corruption, which is one of the biggest and one of the most serious problem in our country. There are another issues I would like to mention, which are clearly important and we would like to change them. I am speaking about the problems like big differences between poor and rich people across the whole country, low level of education, low standart of living in some parts of the Mexico, high unemployment, an many others. And that's why these organizations were created.
- The important step in respect for human rights is, that within the Mexico's National Human Rights Commission is the Harmonization of the Federal Law regarding the International Human rights Instrument. There are several programs with the Harmonization.. Among them I can mention right of women to a life without the violence, rights for people with disabilities, rights for indigenous people, rights for children, justice for adolescents, prevention of discrimination and equal protection, the prevention and punishment of the forced disappearance of persons and the prevention and punishment of torture.

- The signing the Declaration of Human Rights we associated with the 183 other countries that we want human rights to be clear for all and equal for all and that we respect them as all the countries shloud do it according to the UN Declaration of Human Rights.
- In June 2011 we have participanted in the Communiqué of the First Curacao International Imbudsmen Conference, which took place in Curacao. At the conclusion of the conference the communiqué containing conclusions regarding the rule of confidentiality, the protection of the whistleblower and recommendations for the government and the ombudsman was issued. In 2007 we signed the Convention on the rights of persons with disabilities, which elaborate in detail the rights for persons with disabilities and set out a code of implementation. Mexico, as well as other countries, we made an agreement by signing the documents mentioned above, that we have an responsibilty for respecting the human rights. Every state, every natianal governments we are committed to obey every single rule or conclusiones of declarations.
- With these instrument we want to protect our people, we want justice for our people and that is why, firstly we are trying to solve the problems regarding the broking of human rights with non-violent way and complying with obligations established in declarations. I think, that in our country we understand the human rights as any other country and and I agree that is very necessary to find the way how to establish the rules and how to achieve the binding character for the Declaration of the human rights so that in case of the breaking the law every state will be responsible and will suffer the consequences.

In the section *Proposals*:

For the first proposes, I would like to mention that, as I mentioned above, in our country we have an institutions to solving problems concerning about the breaking the law and every case have been solving and on the basis of its severity were also set the penalties for those who were responsable for the breaking the law. - To sign an international accord for setting the universal rules would be helpful in creation of the international tribunal with the uniforme rules for everyone, but changing the legislation of states could be quiete difficult. As an example I could mention, that Mexico abolished capital punishment in 2005 and from that time there were some attempts to reinstating capital punishment for some crimes, especially for murder and kidnappers, but this debate is in my opinion pointless. With capital punishment, the country is breaking one of the most important right, and that is right to life, which is established in the Universal Declaration of Human rights. I think that this will be very difficult to reach a consensus in creating the legislation of states with law permiting the execution of capital punishment, euthanasia or media suppression and many others.
- With third statment I can agree because I think that the work of NGOs is important in every coutry as also in our country. We should support the work of NGOs in our state and than with their support we can achieve better understanding of human rights.
