

Propositions to 3rd Draft

The United States of America accepts an opportunity to participate on Forum for 21st century. We consider the situation of Bashar Hafez al-Assad regime in Syria very alarming. We are very thankful for the possibility to express our standpoint on this problematical issue and so that help to find the right solution for this problematical situation.

The United States of America commends the disagreement with the regime that is functional in Syria. We declared that all the responsibility of the situation in Syria is subject to Assad. The proofs about the using chemical weapons directly indicate to the Assad regime and now it is inconceivable that the situation in Syria is goings to be the same as was before the civil war.

The United States of America adopts the US-Russia deal on chemical weapons to prove that our target is not just a power threat but we prefer to limit the chemical threat.

The United States of America commends to the consecutive issues:

1. The hostilities are required to stop

We calls upon to stop the hostilities in Syria with the degradation of Assad regime and with the claim of new democratically elections in the country. We want to claim this target with the weapons embargo on the Assad army. The United Nations Department of Peacekeeping Operations (DPKO) continues to conduct contingency planning for possible peacekeeping or peace enforcement operations that could be authorized after the widespread fighting currently raging across Syria has ended. However, DPKO will have a hard time obtaining sufficient troops to serve in a post-Assad Syria. A post-Assad Syria will likely pose significantly greater risks to peacekeepers than those currently faced by personnel along the Syrian border, and may discourage many nations from participating in a U.N. peace operation. We agree with the statement that the mission should be a joint mission between all the member states of this Forum, sent to negotiate a cease-fire with all sides of the conflict, which will be willing to negotiate a truce. The USA will participate in generating a substantial agreement between the member states on all the most pressing issues before they embark on this peace-making

mission. We are going to participate on the mission from all member states and we will represent a unified diplomatic force, which will have clear goals and boundaries preagreed upon. The USA agrees with the defined time-line of events in Syria in ANNEX A. Model Conference - Modelová konferencia

2. The end of hostilities is to be assured with a weapons embargo

The USA appreciates the progress on the dismantlement of chemical weapons of mass destruction in Syria. It is important for continuing peace is to be safeguarded a weapons embargo needs to be enforced. We suggest the weapons embargo for Assad army, but not for the insurgents. We support the insurgents in the degradation of Assad regime. In the point of outstanding weapons contract we disagree with postpone of weapons contract for the insurgents on the other hand we agree for Assad regime.

3. Free and equal elections shall decide the future of the country

We agree that the solution has to be democratic. The USA calls upon that the realization of this ideal is free and equal elections, in which all sides of the Syrian political spectrum can take part and where every citizen can cast a vote for her/his preferred political party. The United States of America will not interfere in any way in the process of democratically elections in country, and we will safeguard the adherence to principles of the freedom and equality of elections. We agree that the future political landscape of Syria has to be decided by the independent and sovereign Syrian citizenship. We agree (after the negotiation with all member states of Foum) with the statement that the elections shall not take place before the term in office of President Assad ends, or not, but only if the results of the peace-making mission make a sooner date available.

4. Armament-sector inspections must be allowed,5. Humanitarian aid must be given

The United States of America concurs with the proposal, that UN neutral unit of the UN, during the transition period, have to have access to such building and places of Syria witch are connected to the sectors of the economy which are indispensable (or are used as such) for the production, import and storage of goods and machinery required for the conduct of a war. These inspections shall make indubitable that every side of the conflict is following the principles of a truce and is not engaging in retribution-like behavior. We declare that is



important to prescribe any further action that the major powers agreed upon. It shall be made public to the international community and it should have as its primary goal the achievement of a truce in Syria. In point of "Humanitarian aid must be given" we agree with the aid provided by the third party non-governmental organizations.

6. A memorandum must be signed

We take notes of the signification of signed memorandum. We believe that in the Forum we are going to make the consensus with the all major state. We understand that situation in Syria is alarming and dangerous for the rest of the world.

We the United States of America support the Forum for 21^{st} Century and we hope that this situation will be solved in short time.
